  - A. Nomination for Chair
    - 1. 5 minutes for opening speeches, 5 for questions
      - -- Revelle Representative: I like what SFAC has done so far. I would like more outreach so students understand how fees work and where they go. I want to promote a sense that money is going to useful areas. I would also like to work more closely with units to explain what SFAC cares about most during proposal presentations. We can create a guide. Units should aim to get information all in one sitting instead of requiring us to have follow-ups.
      - 1. Warren Representative: From the presentations we saw this quarter, what showed you that the presentation got the relevant evidence and did their due diligence to SFAC?
      - I. Revelle Representative: For example the Peer Mentorship program, they repeatedly showed data on unique students being reached and the reason why an FTE would be necessary. It was easy for us to see how the program currently functioned and how easily/quickly it would be to expand into other areas. On the other hand, the Dialogue Circles were not as good as it could have been. It didn't show a cohesive story with strong differentials. As a result, we couldn't quite see the need and therefore it was not rated as high.
      - 2. Chair: I'm curious as to your upcoming commitments and how SFAC would fit into there?
      - I. Revelle Representative: Classes-wise, I believe my academic commitments would be a large issue. My time would be split between managing my grades and doing SFAC. I'm thinking that if I could participate in a variety of committees alongside these two commitments,
      - 3. Provosts: How do you think next year's SFAC will be different since classes may or may not be remote at various points of next year?
      - I. Revelle Representative: If this were to continue, I think we would have to look towards pushing units to digitize their resources. Making sure

that services we fund are able to have an online presence and provide students with resources is something I'd work on. We want to make sure students of all time zones can have equal access to these resources.
