#### **Update on Potential Needs**

- 1. The Zone
  - a. Sent in a funding request for basics such as computers, a bean bag, iPod, parking passes, etc. for a grand total of \$5,000
  - b. Can carry over if physical expansions are approved
  - c. Consensus to suggest to the VCSA to fund the Zone's request
- 2. Bike sharing program
  - a. UCLA is starting a bike sharing program this year, in coordination with the city of Los Angeles
    - i. UCLA is paying for a portion of the city's program to be included with the whole city
  - b. Speak with the bike sharing program about maintenance costs and more details
  - c. Pros and cons of having a private company compared to transportation services expanding their own services?
    - i. Private companies are more expensive, but they have a strong support network that can deal with most issues
    - ii. If done with transportation, there are concerns that it won't get the attention and publicity it deserves, especially since their main focus is the parking issue

#### **Discussion of Charter/Bylaw Reform**

- 1. Absence information more suited in the charter or in the operational procedures?
- 2. In the process of updating the "Alternates" section and changing alternates to trainees
- 3. Stipend information preferred to be in the operational procedures rather than the charter
  - a. Discussion of stipends if a member forfeits their membership early
- 4. SFAC MOU
  - a. Includes language regarding referenda procedures
  - b. Are the expectations of each body appropriate? SFAC, VCSA, and CFO

  - i. Possibility of adding a clause in that special case
